Place the PAK'NTAINER® wherever needed, whenever needed... temporarily or permanently... no anchoring, no concrete pad, no special surfaces required. It can be used alone or to "fill the gap" in combination with other units. The container is tapered to achieve superior compaction ratios and aid waste ejection which eliminates excessive wear and tear on collection trucks. Liquid-tight construction helps ensure a sanitary environment. The drain allows water to be removed lowering disposal costs.

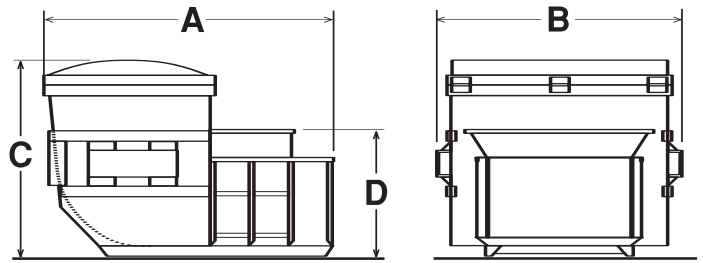
Pak'ntainer with Optional Plastic Lids enclose hopper to keep contents in, rain out.
